## I have read the Privacy Policy pursuant to EU King 679/2016

Pursuant to art. 13 of EU RE 679/2016 hereinafter referred to as the Regulation, a rule which regulates the protection of persons and other subjects with respect to the processing of personal data which the "Ricominicio da tre" Social Promotion Association will come into possession of, we inform you of what follows:

### **1 Data controller and contact method**

Pursuant to article 4 of the Regulation, the "NEW STAR" Social Promotion Association with registered office in Milan at via Antonio Mosca n. 30, C.F. 11594550961 is the Data Controller of the Data relating to its Members. For communications or requests, the association can be reached via e-mail at info@newstarmilano.it, or by telephone at the following numbers: +39 3929092029

### **2 Categories and types of Data collected and processed**

The Data collected and processed by the "NEW STAR" Social Promotion Association may include common personal data requested from Members (such as name, surname, place and date of birth, tax code, residence address, telephone number, email).

Medical certifications relating to non-competitive sporting activities may also be collected, reporting only the indication of the suitability of carrying out the activity, therefore to be considered common data pursuant to the Communication from the Guarantor to the Italian sports medical federation dated 31/12 /1998. Instead, the report of unfitness, which presupposes in the interested party either the presence of pathologies or in any case the need to avoid potential risks induced precisely by non-competitive practice, undoubtedly takes on the connotation of sensitive data, pursuant to art. 22, paragraph 1 of law no. 675/1996 and the current Regulation and will be treated as such.

### **3. Purpose and legal basis of the processing and nature of the provision of data**

Personal data is processed for:

- a) Conclude requests for enrollment in courses and contracts for the Data Controller's activities;
- b) Fulfill pre-contractual, contractual, fiscal and sporting obligations (such as membership procedures at sports promotion bodies) deriving from existing relationships;
- c) Fulfill the obligations established by law, by a regulation, by community legislation or by an order from the Authority;
- d) Exercise the rights of the Owner, for example the right of defense in court;
- e) Send via e-mail and/or Whatsapp and/or text message and/or telephone contacts, communications relating to the membership or the services offered by the holder.

The legal bases of processing for purposes a), b), c) and d) are art. 6.1.b) and 6.1.c) and 6.1 e) of the Regulations. The provision of the Data for the aforementioned purposes is optional, but any failure to provide the Data itself and the refusal to provide it would make it impossible for the "NEW STAR" Social Promotion Association to associate the member.

The legal basis for the purpose referred to in point e) is art. 6.1. f) of the Regulation, the processing carried out for the purposes of commercial communications in relation to products or services of the Data Controller similar to those used by the user, the "NEW STAR" Social Promotion Association may use the e-mail addresses pursuant to and within the limits permitted by art. 130, paragraph 4 of the Privacy Code (Legislative Decree no. 196/2003) and by the provision of the Guarantor Authority for the protection of personal data of 19 June 2008 even in the absence of explicit consent. Without prejudice to the possibility of objecting to such processing at any time, initially or on the occasion of subsequent communications, easily and free of charge also by writing to the contact details indicated in the contact methods of this information, as well as obtaining immediate feedback confirming the interruption of this processing (art. 15 of the Regulation).

There is no automated decision-making process, nor any profiling activity referred to in Article 22 of the Regulation.

### **4. Methods of data processing.**

In relation to the indicated purposes, the processing of the Data takes place using manual, IT and telematic tools with logic strictly related to the purposes themselves and, in any case, with methods such as to guarantee the security and confidentiality of the Data itself, in addition to compliance with the specific obligations established by the legislation.

The Data will be processed in compliance with the principle of lawfulness, correctness, relevance and non-excessiveness, in accordance with the provisions of the legislation on the protection of personal data.

The processing will be carried out by formally appointed and adequately trained personnel..

### **5. Scope of communication and dissemination of Data, recipients and transfer of Data and Data Processors**

For the aforementioned purposes, the Data will be communicated and processed by authorized persons, and may also be transferred electronically to II level bodies with which the association should affiliate for the appropriate legal requirements, which as Autonomous Data Controllers, will provide for any Memberships /accreditations both for insurance purposes and for registration in specific public registers.

The Data may also be communicated to third parties who may operate as independent data controllers or be appointed Data Controllers pursuant to Article 28 of the Regulation and in particular to consultants where this proves necessary for fiscal, administrative, contractual or technical reasons. or for needs protected by current regulations.

Finally, the Data may be shared with authorities, bodies and/or subjects to whom the Data must be communicated pursuant to legal provisions or orders of authorities. These authorities, bodies and/or individuals will operate as autonomous data controllers.

The Data will not be disclosed.

The periodically updated and complete list of managers appointed for the processing of the Data can be requested by sending an email to the Data Controller at the contact details indicated above.

### **6. Transfer of Data to international organizations and/or countries outside the EEA**

If the Data is transferred to international organizations and/or countries not belonging to the EEA, the processing will take place according to one of the methods permitted by current legislation, such as for example the consent of the interested party, the adoption of Standard Clauses approved by the European Commission, the selection of subjects adhering to international programs for the free circulation of data (e.g. EU-USA Privacy Shield) or operating in countries considered safe by the European Commission.

## 7. Data Retention

The Data will be stored on paper and/or IT media for only the time necessary for the purposes for which they were collected, respecting the principles of conservation limitation and minimization referred to in Article 5, paragraph 1, letters c) and e) of the Regulation.

The Data will be stored to fulfill regulatory obligations and pursue the aforementioned purposes, in compliance with the principles of indispensability, non-excess and relevance.

The "NEW STAR" Social Promotion Association may retain data after the termination of the contractual relationship to fulfill regulatory and/or post-contractual obligations; subsequently, once the aforementioned reasons for the processing cease to exist, the Data will be deleted, destroyed or simply stored in anonymous form.

## 8. Rights of the interested party.

In relation to the aforementioned processing, each interested party may exercise the rights referred to in articles 15 to 22 of the Regulation.

In particular, the interested party has the right to ask the "NEW STAR" Social Promotion Association for access to their data, for rectification or cancellation of the same, has the right to object to the processing or to request the limitation of processing in cases provided for by article 18 of the Regulation and to obtain their Data in a structured, commonly used and machine-readable format, in the cases provided for by article 20 of the Regulation.

The interested party may also revoke at any time the consent given pursuant to article 7 of the Regulation, as well as lodge a complaint with the Guarantor Authority for the protection of personal data pursuant to article 77 of the Regulation, if he believes that the processing of his Data is contrary to current legislation.

In cases of opposition to the processing of Data pursuant to article 21 of the Regulation, the "NEW STAR" Social Promotion Association reserves the right to evaluate the request, which will not be accepted if there are compelling legitimate reasons to proceed with the processing that prevail over the interests, rights and freedoms of the interested party.

Requests must be sent in writing to the "NEW STAR" Social Promotion Association at the addresses indicated above.

This information may be updated upon the entry into force of new provisions or sector regulations or if the purposes, methods or any aspect concerning the processing of data change for which the interested party has the right to be informed and possibly to whose consent will be required for those purposes pursuant to art. 6.1 a) of the Regulations.
